Expression of interest for installation of CC TV camera

Sealed expression of interest is hereby invited in plain paper from the experienced and resourceful firm/ person for installation of CCTV Camera in the premises of Tripura medical college & DR.BRAM Teaching hospital. The interested person / firm has to submit detail project report regarding installation of camera / Name/ Brand of camera with capacity/ mode of operation including impart of training of staff of Society in respect of operation of machine/ recording of photograph/ preservation thereof etc in technical bid part with the expression of interest. No of CC camera to be installed 43 (Fourty three) nos which may be increased if considered necessary later on. Warranty period should be mentioned in the technical bid. Proposal including rate of CAMC for next five years after warranty period should be furnished with financial bid. Last date of receiving offer is up to 3.00 PM on 30th August, 2016. The expression of interest should be submitted in three cover system containing three parts as deailed below:

PART I: Pre Qualification bid to be kept in first sealed cover marked " Pre Qualification bid"
Pre Qualification bid contains-

i) Copies of a) Trade licence b) Vat registration certificate c) PTC. These certificates are to be submitted along with expression of interest.

ii) EMD of Rs.35,000/-in the form of bank draft in the name of Society for Tripura Medical College & Dr. BRAM Teaching Hospital , Hapania,Agartala on any nationalized bank is to be furnished along with the expression of interest which will be treated as security deposit incase of successful Tenderer.

PART II: Technical bid to be kept in second sealed cover marked " Technical Bid"

i) Technical bid contains original literature of the instruments and camera with specification.

ii) Experience certificate from the authority where installation of such camera done earlier.

iii) Certificate of authority of Manufacturer company.

iv) Guranty/Warranty period: The bidders must include comprehensive warranty for 02 (two) years for the equipments from the date of completion of satisfactory installation. Bidders shall submit rate of CAMC for 5 years after expiry of two years warranty period for the equipment. Rate of CAMC per yaer should not be more than 3% of total cost of the machine. Failure to comply with this condition might entail rejection of the bids. The payment of CAMC will be made on bill basis after submission of satisfactory service report duly signed by the in-charge of respective department.

v) One work order/ supply order in support of earlier experience, if any, of the bidder.

PART III) Commercial bid to be kept in third sealed cover marked " Financial bid"

i) Rate should be clearly typed both in words & figures against each item & should be quoted in currency.

Part I, Part II & Part III should be kept in a separate cover.

Thereafter the covers shall be kept in one big cover and sealed. Bidders should take care in putting the documents as described; otherwise the bids will not be considered. The Chief Executive Officer , SFTMC,Hpania Agartala will accept only one cover duly sealed and stamped at the holdings. The cover should read expression of interest for installation of CC Camera for Tripura Mdical College & Dr.BRAM Teaching hospital, Hpania, Agartala also indicating thereon :

i) Reference No. of the Tender

ii) Due date for submission of the tender.

iii) Name of the firm with address , phone & fax , e-mail.

Plaese note that prices should not be indicated in the " Prq-QualificationBid" and" Technical Bid".

Note:- Tenders submitted without following three bid system procedure as mentioned above will be summarily rejected.
