Terms & Conditions

1. Rs. 10,000/- is to be deposited as an EMD in the form of Demand Draft on any Nationalized Bank in the name of SFTMC & Dr. BRAM Teaching Hospital, Hapania along with quotation. This Earnest Money will be kept as security deposit for successful bidder and for unsuccessful bidder this EMD will be released as soon as rate is finalized.
2. Copies of a) Trade License b) GST Registration Certificate c) Aadhar Card d) PAN Card are to be submitted along with Tender.
3. Rate should be clearly typed both in words & figures against each item & should be quoted in Indian currency.
4. F.O.R Door Delivery.
5. All booking to be done within 24 hours of the intimation provided to the agent via email and/or supply order and/or any other mode of communication as decided by the society time to time.
6. 1% penalty will be charged for every day of delay or a part thereof for maximum a period of 15 (fifteen) days after stipulated date of supply, thereafter the bidder may be terminated for further supply of orders.
7. No Price hike will be entertained.
8. Society reserves the right to cancel any quotation even of the lowest one without showing any reason.
9. Bidder may quote discount for each quantity.
10. Society reserves the decision to accept best competitive price for quantity in count.
11. Society reserves the decision to accept / reject any time in the tender.
12. All tickets & itineraries details must be shared over the pre-defined E-mail ID of the Society & the phone numbers of the traveler(s), and/or at the premises of TMC, Hapania at the time of purchase by the agency.
13. Bidder with past experience into such ticketing services may be preferred.
14. The supply of tickets shall be on credit basis to SFTMC, and invoices will be raised later for payment.
15. No advance payment for any ticket booking may be allowed.
