Eligibility Criteria for appearing in the Counselling for State Quota Domicile Seats (Annexure-C), Guideline for Online Counselling (Annexure-D), Flow Chart of Counselling & Allotment process (Annexure-E), Registration Fees (Annexure-F) and Sample Procedure of Distribution of Seats (Annexure-G). Matrix of Round-1 to MOP UP Round (Annexure-H), Steps of Online Counselling (Annexure – I) are being Uploaded in the Directorate of Medical Education Website www.dme.tripura.gov.in. The Seat Matrix in Annexure- A will be uploaded shortly before Counselling.

Aspirants NEET-UG-2020 qualified Candidates will be informed accordingly to register their names along with Registration Fees as indicated in an **Annexure-F.** Candidates are also requested to go through every Annexure minutely before filling up their Application Form and deposit of Registration Fee.

Only registered candidates will be eligible for appearing in the Counselling. Admission on allotment are subject to condition that all the Uploaded documents are found correct during the physical verification.

The reservation for PwD candidates, EWS and WESM will be applied in the Seat Matrix as per Rules. Candidates belonging to PwD category shall have to produce their respective original Authentic Certificate from the Disability Board of Agartala Government Medical College & GBP Hospital, Agartala or any other Disability Board recognized by Medical Council of India (MCI) for verification. Candidates belonging to ST/SC/ or OBC (for All India other than Tripura Domicile) and candidates belonging to eligibility criteria from 1 to 5 shall have to produce their original Authentic certificate during verification. Reservation for WESM candidates and EWS candidates will be applicable as per Rules. Certificate Format of PwD, & EWS are furnished in **Annexure(J, K)**.

The Portal of the Online Counselling will be declared shortly. Please see all the Annexures (C to K) as Uploaded for ready reference. Annexure-A comprising Schedule of the Counselling and Annexure-"B" comprising Seat Matrix which will be uploaded shortly before Counselling in the website www.dme.tripura.gov.in as per availability of seats in various courses at that point of time. Eligible aspirant candidates are requested to read the Notification and Annexures carefully positively before filling the Online Application Format and Registration for the 1st Round of Counselling and also to visit the said website regularly for the Date of Registration, Counselling Schedule, Notice/Notification and News/Events or any Modification of Schedule/Steps/Guidelines/Seat Matrix from time to time in the website www.dme.tripura.gov.in All seats will be distributed as per Merit List of Registered eligible candidates as per Norms, Guidelines of NEET UG 2020, Govt. of Tripura and Govt. of India as applicable.

ELIGIBILITY CRITERIA FOR APPEARING IN THE COUNSELING OF TRIPURA STATE QUOTA/DOMICILE SEATS OF MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSSION 2020

Eligibility Criteria:

Eligibility Criteria for appearing in the Counseling of State Quota/Domicile Seats for NEET-UG qualified candidates (NEET-UG-2020 for academic session 2020-21) for admission to Medical/Dental/AYUSH/BASLP courses.

Clause - 1.

The applicant must be an Indian Citizen and a Permanent Resident of Tripura. The applicant or his/her parents must have been residing in the State of Tripura continuously for not less than 10 (ten) years immediately prior to the date of making application for appearing at NEET-UG. The applicant should not have applied for domicile (as per NEET Brochure) of any State other than Tripura.

Clause - 2.

Children of All India Services Officers borne in Tripura Cadre and the Children of the Employees of the State Government posted outside Tripura will be eligible to appear at the Counseling irrespective of their prior stay in Tripura.

Clause - 3.

In case a candidate is not permanent resident of Tripura but his / her parent is either on deputation as Officer/employee to the Govt. of Tripura or an Officer/employee of the Central Govt. working in Tripura and has served in Tripura continuously for a period of 3 (three) years or more prior to appearing in the qualifying examination from any School/Institute of Tripura

Clause - 4.

In case of wards of Ex-servicemen, either the candidate or his/her parents must have been staying in Tripura continuously for not less than 5 (five) years immediately prior to the date of making application for appearing at NEET Examination and the candidate must have passed H.S(+2 stage) Examination in the year of NEET Examination from any School/Institute in India affiliated to Board recognized by Govt. of India/Govt. of Tripura with subjects in which he/she desires to appear in

Clause - 5.

Children of serving Defense Personnel (Army/Navy/Air Force) hailing from Tripura are also allowed to appear for Counseling provided that their children should have stayed in Tripura continuously for not less than 5 (five) years immediately prior to the date of making application for appearing at the NEET Examination and that the candidate must have passed the H.S. (+2 stage) Examination from any Institution of Tripura with the subjects in which he/she desires to appear in the NEET.

In case of any doubt that may arise regarding authenticity of domicile/period of domicile, the same may be got verified from the issuing authority.

GUIDELINES OF ONLINE COUNSELLING FOR MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSION 2020

The Directorate of Medical Education, Health & Family Welfare Department, Government of Tripura has formulated the following guidelines to be adopted for distribution of seats Professional Degree Colleges for MBBS/BDS/AYUSH/BASLP Courses through Counseling process by the Counseling Committee for distribution of seats in concerned Medical Colleges/Institutions.

- After official publication of results of NEET UG, Directorate of Medical Education(DME) shall notify for the registration of the eligible candidates <u>in the</u> <u>Tripura Counseling portal www.mcc.tripura.gov.in</u> to prepare the merit list of the registered candidates and for counseling for admission in MBBS/BDS/AYUSH/BASLP Courses.
- 2. The Directorate of Medical Education shall conduct counseling of the qualified / eligible candidates for admission into the different Professional Degree courses in Colleges/Institutions inside and outside Tripura every year.

3.

- (i) State Quota Seats Reservation as per State Reservation Policy.
- (ii) For the seats allocated by the Central Government (if any) to the State as State Quota Seats, reservation policy will be adopted as per directives of the Govt. of India.
- (iii) A.I.Q seats if reverted to State Quota seats reservation policy will be adopted as per State reservation policy

After verifying the roster by the Nodal Departments concerned Officers of the State quota seats, the reservation of the seats for the SC, ST, WESM (Wards of Ex-Servicemen), EWS(Economy Weaker Section) & PwD(Persons with Disability) candidates will be clearly mentioned in respect of each Institution / College.

- 4. The Directorate of Medical Education after getting the seats status from the sponsoring Colleges, will notify the status of the available seats for NEET UG 2020 eligible candidates for the purpose of counseling.
 - (a) Eligibility Criteria for State Quota seats will be as per Eligibility Criteria stated in Annexure- "C"
 - (b) The procedure of online counseling shall be as follows as per chronological order:-
 - After the declaration of NEET Results DME will arrange to collect the merit list from DGHS.
 - 2. The digitized records will be processed by the NIC Agartala under supervision of Common Counselling Committee(CCC) for preparing (preliminary) Tripura State Merit List (TSML) i.e. list of candidates who have opted under Tripura domicile category in NEET, strictly in order of inter se merit.
 - 3. (Preliminary) Tripura State Merit List (TSML) will be published by DME in the websites: www.dme.tripua.gov.in & www.mcc.tripura.gov.in

- 4. Simultaneously CCC will publish notification for registration in the Tripura State counseling as well as registration for 1st round of counseling for (a) State domicile/State Quota seats and (b) 20 seats of the TMC for other than Tripura domicile candidate.
- 5. Registration portal will be kept open for a scheduled period as conveyed by National Testing Agency (NTA)/MCI during which candidates have to register their names for (a) State domicile seats/State Quota Seats or (b) 20 (twenty) seats of TMC for candidates of All India other than Tripura domicile.
- 6. After registration process completes within the schedule date (i) the final Tripura State Merit List and (ii)The merit list of All India other than Tripura domicile (for 20 seats in TMC) will be published.
- 7. CCC will notify the dates of "choice filling and locking" for the registered candidates.
- 8. Then the CCC will proceed for online allotment of seats
- 9. After allotment of seats, Issuance of Nomination will be arranged from DME for the State domicile/State quota seats. Issuance of Nomination for the 20 seats for All India other than Tripura domicile will be arranged from DME. All admission to concerned Institutions as per allotment & Nomination is subjected to verification of original documents. Any want of original document. Any faulty, Any tampering, forgery in connection with original documents or any faulty eligible document if found during physical verification or at any point of time will lead to cancellation of Allotment/Nomination or admission in connection with that particular candidate and may be further processed as per law.
- 10. After receiving the Nomination that by candidate himself/herself from the Directorate of Medical Education the candidate will proceed for admission to the allotted college and have to fulfill the admission criteria of respective College/ Institution after the physical verification in the allotted Institution.
- 11. The seats not availed by the candidate in the 1st round of counseling or availability of new seats after notification of 1st counseling, will be carried forward for the 2nd / subsequent Round of Counselling.
- 12. Registration for counseling in the link <u>www.mcc.tripura.gov.in</u> is mandatory to get a seat by a candidate through Counselling.
- 13.A candidate, who surrenders his / her seat offered in the first round of counseling with an intention to avail better seat in the second and subsequent round of counseling, if any takes place by the counseling committee, shall not claim the college of his / her choice as per his / her original rank of the first counseling. He/she will have to accept the seat in the college which is available during the second counseling or subsequent counseling as allotted as per candidates filling of choice as per merit. The same method shall be applied in case of a candidate who sought permission to abstain from first round of counseling for allotment of seat in second round of counseling or subsequent and also for the candidates who does not accept i.e. refuse seat allotted to them in the first round of counseling. For example if a candidate who may have topped the NEET- UG in the first round counseling but surrendered his/her seat with the intention of appearing in the subsequent round then he/she cannot claim in the 2nd Counseling that on the basis of rank he/she should be given a college of his / her choice made by the Round 1. He / she will now rank with the others who are in the second counseling and if in the second counseling he / she is eligible as per merit at Round 2 to a college of his/her choice, he / she will get it. To clarify it further, supposing an unreserved category who is number one in the list could get a college of his/her choice in the first counseling, but he/she does not accept the offer and surrenders the seat. In that case, when the second counseling takes place, there is no seat left under the unreserved category in the college of his/her choice. He/she will have to accept the seat in the college which is now offered to him/her in the second counseling & subsequent counseling as per the availability of seats.

- 14. All Rounds will be called with the availability of seats at that point and will be furnished accordingly.
- 15. A Candidate who got admitted to an allotted seat during first round of counseling but subsequently intends for resign/ surrendering the seat shall have to apply in written to the Chairman, Counseling Committee or Director of Medical Education for surrendering the seat within 2(two) days positively or as decided by MCI/NTA/Competent authority excluding the date of receiving of the nomination form from the counseling committee/DME. A surrender certificate will have to be obtained from the admitting Institutions and must be submitted to the office of the Directorate of Medical Education within 2(two) days of the last date of admission of that Round along with the said Application to Chairman, Common Counselling Committee/DME.
- 16. After completion of first round of counseling, the Directorate of Medical Education shall inform about the vacancy status of seats in respect of course/branch and category as informed from the Medical Colleges/Institutions so that the next course of action can be taken by Directorate of Medical Education for second and subsequent counseling. All the sponsoring college shall have to inform the status of the seats distribution & vacancies, Surrender in details within stipulated time to the Chairman of the Counseling committee for preparation of subsequent round of counseling as well.
- 17. The candidates shall have to be present during the period of the document verification process in the allotted Institution before admission.
- 18. Admission of Candidate to a certain College / University will be subject to the fulfillment of other eligibility/Admission criteria, of the respective admitting College/University/Institution, including the cut-off marks in NEET UG 2020 of the respective category, Age of the candidate, beside other NEET Eligibility.
- 19. There will be no waiting list of the candidates at the time of counseling. In successive occasions, fresh counseling will be held as per procedure and Notification will be published in the website of Directorate of Medical Education.
- 20. No separate call letter will be issued to any candidate.
- 21. If a Candidate got admitted to an allotted a seat in the current year whether in or outside the State on the basis of the result NEET -UG-2020, he/she will not be entitled for allotment of another seat unless he / she has surrendered the earlier allotted seat in writing within the specified time to the admitting authority and produce the Surrender certificate to Directorate of Medical Education in due time.
- 22.If any seats viz MBBS/BDS/BASLP or any AYUSH UG Medical courses be allotted for Tripura after publication of seat matrix, meant for that particular counseling, then those will be placed in the seat matrix of the next round of counseling i.e. 2nd round / MOP-UP rounds/Stray vacancy round.
- 23. Without production of the original relevant certificates a candidate shall not be allowed for admission to an allotted Institute.
- 24. Tripura State Merit List will be published on the websites: www.dme.tripura.gov.in and www.mcc.tripura.gov.in by the Chairman of the Common Counseling Committee.
- 25.A candidate applying under Clause-1 of Eligibility Criteria should not apply for domicile seat of any State other than Tripura. A self-declaration in this regard will have to be given in the online State Counseling registration form. If the candidate is found to violate these domicile / or other eligibility criteria by supplying wrong/false information, his / her candidature of Counselling/Admission/Allotted/Nomination is liable to be cancelled at any time.


- 26. Proper authentic certificates shall have to be possessed by a candidate and shall have to be shown at any point of time including during physical verification in support of any particular Reservation Category, State domicile Eligibility, Qualifying marks and Rank other eligibility conditions, Date of Birth etc.
- 27. Candidates are instructed to visit Directorate of Medical Education website. **www. dme.tripura.gov.in** regularly for any Updates, Notifications, Modifications, Notices issued from time to time regarding the said Counselling.
- 28. All candidates will have to submit an Undertaking stating that he/she is applying for State Quota Domicile seat of Tripura only and never applied or will apply for any other State Quota seat for this academic session of 2020-21(this is applicable for NEET successful candidates applying for Tripura State Quota/Domicile seats only.
- 29. Reservation category of ST/SC for State Quota/ Domicile seats will be as per State of Tripura Reservation Rule .
- 30. Reservations of EWS /PwD/WESM will be as per existing Rule and Guidelines as applicable for Tripura State.
- 31. All Certificates of Reservation should be in Prescribed Form signed by the Prescribed authority with validity (wherever applicable) as per Rule.


Flow Chart


Scheme of online Tripura State (Domicile) & Non* Domicile Quota UG Counseling -2020

PROCEDURE OF DISTRIBUTION OF SEATS IN THE COUNSELING FOR MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSION 2020

- 1. Tripura State Merit List (TSML) of registered candidates will be generated. The candidate eligible for UR category seat as per merit can opt as per choice filling any seat from the available seats meant for UR and he / she can opt any seat of a particular course according to his /her choice from any of the available Colleges. Candidates will be allotted seats as per merit if they fulfill other eligibility criteria. The seats of UR category seats will be distributed first as per Merit List followed by EWS, ST, SC, PwD and WESM category seat as per availability.
- 2. If the candidate belongs to ST/SC category with eligible Rank/Marks(as per Merit List) he / she will be selected for a seat of a particular course in any one of the following cases:-
 - (a) A candidate of ST/SC category will be offered to opt any seat from the available seats meant for UR and he / She can opt any seat of a particular course according to his/her choice from any of the available courses meant for UR. In that case the seat which is allotted to him/her as per Merit then the UR seat would be reduced from the seats meant for UR and not from the seat reserved for the ST/SC category.
 - (b) A candidate of ST/SC Category will be offered to opt any seat from the available seats meant for UR and he / she can opt any seat of a particular course according to his / her choice from any of the available courses meant for UR. But if he / she finds that seat meant for UR for a particular course of his choice is available in a particular Institution which he/she does not prefer, but seat reserved for ST/SC category for that course is available in his / her preferred college / Institution, then he / she can opt a seat reserved for ST/SC Category in his /her preferred College. In this case, his/her admission should not be counted against the quota reserved for ST/SC Category, ie. No seat can be reduced from the quota of concerned reserved category. As the candidate is eligible for UR seat on his/her own merit, one UR seat will be reduced from UR Quota and the reduced seat would be compensated to the seats reserved for the ST/SC category so that the number of seats reserved for ST/SC category for this particular course is not reduced by the aforesaid case.
 - (c) If no seat meant for UR is available for a particular course, say MBBS, then a candidate of ST/SC Category will be offered to opt any seat from the remaining courses meant for UR and including the seats of MBBS which are available for ST/SC Category. The candidate can opt any seat of a particular course according to his / her choice from any of the available courses meant for UR. But if he/she opts a seat of MBBS from the seats reserved for ST/SC, then the seat would be reduced from the seats reserved from ST/SC. Then the Committee shall select the candidate for the respective seat of that course that he/she will opt provided he/she fulfills the other eligibility criteria.
 - (d) If all seats meant for UR are exhausted, then a candidate of EWS ST/SC Category will be allotted any seat from the available seats reserved for EWS ST/SC as per merit and choice filled up by the candidates provided he/she fulfills the other eligibility criteria.
 - (e) The vacant seats in reserved category will be filled up as per approved roster and
 - (f) Seats reserved for PwD/WESM will be distributed as per norms/Roster and guideline.

GENERAL INFORMATION REGARDING STEPS OF ONLINE COUNSELING FOR UNDER GRADUATE COURSES OF MBBS, BDS, BASLP & AYUSH COURSES FOR THE SESSION 2020

- 1. Registration is a must for a candidate to be eligible for the Online Counseling.
- There will be two rounds of counseling or as per any other notification from GOI (Govt. of India) / MCI (Medical Council of India) / NTA (National Testing Agency) / Hon'ble Supreme Court of India issued from time to time.
- 3. There will be two rounds of allotment viz. 1st Round & 2nd Round followed by Mop-Up round if needed, followed by stray vacancy round if needed. The stray round will be organized by respective college in accordance with the merit list prepared and sent from Director of Medical Education.
- 4. Every round is fresh round. The candidates who did not/could not register their names in the 1st round of counseling must register their names in the 2nd round of counseling and allotment of each round will be against the available seats for that particular counseling only.
- 5. Candidates once registered in the Round I (1st round) of counseling need not register their names again for the 2nd round of counseling. But Security Deposit for participation in the Second Round Counselling is mandatory.
- 6. Round 1 and Round 2 Counselling will be online and as per seat category in the following order:-
 - (a) UR (b) ST (c) SC (d) OBC (for 'All India other than State Domicile' of TMC).
- 7. The counseling will be as per procedure of each candidate in the order of preference opted for different courses & colleges by a candidate.
- 8. There will be auto up-gradation for the candidates in the Second Round, the Allotment in Second Round as per candidates choice will automatically cancel his/her earlier seat of allotment/admission in Round-1.
- 9. Any seats after 1st round of counseling if remains vacant or new seats be made available by GOI or any other source will be placed in the seat matrix of 2nd round of counseling with proper Educational Notification.
- 10. There will be a Mop Up round if there is any seat still remaining vacant after 2nd round of counseling or new seats become available from GOI or any other source.
- 11. If any seat remains vacant after Mop Up round or new seats become available from GOI or any other source, then these seats will be sent back to the respective college with a merit list in the ratio of 1:10 (i.e. 10 names for each seat vacant in that category.
- 12. The final Tripura State Merit List (TSML) will be prepared from the candidates who have registered in the Tripura Counseling Portal www.mcc.tripura.gov.in Physical Verification of Documents/Certificates etc. will be done by allotted Colleges before admission. Allotment/Nomination will automatically stands cancelled for a candidate, if he/she does not clear Physical Verification process.
- 13. The final Tripura State Merit List will be published on the following websites:
