Expression of interest & Tender Calling for installation & Repair of CCTV

Sealed expression of interest is hereby invited in plain paper from the experienced and resourceful firm/ manufacturer/ supplier/ dealer for installation of CCTV Camera and repairing & properly calibration with fixing the old CCTV camera present in the premises of Tripura medical college & DR.BRAM Teaching hospital.

1. The interested experienced and resourceful firm/ manufacturer/ supplier/ dealer has to submit detail project report regarding installation of new camera / Name/ Brand of camera/ user experience with capacity/ mode of operation including impart of training of staff of Society in respect of operation of machine/ recording of photograph/ preservation thereof etc in technical bid part with the expression of interest.
2. The CCTV offered should be high able to cater latest technological parameters like of various quality and sizes for different locations like indoor/outdoor/ overall lobby coverage, high resolution, long distance coverage, Zoom in & Out, IR sensor enabled, motion movement sensor, night vision, Wifi or wireless technology, centralized storage of footages over server/ DVR/ cloud storage, momentarily power backup etc.
3. The tendered also may quote separately the cost of additional hardware required for full fledged installation & commissioning of the orders, like LED TV, DVR Storage, Cloud Storage/ any additional hardware/ software if required.
4. The interested experienced and resourceful firm/ manufacturer/ supplier/ dealer has to submit cost with all charges of repairing, fixing, calibration of existing approximately 32 Numbers (but not limited to), whichever requires so.
5. Quantity of new CCTV is estimated around 40 Numbers (quantities may vary upside/downside).
6. Warranty period of 24 months should be mentioned in the technical bid.
7. Proposal including maximum rate of AMC for next five years after warranty period should be furnished with financial bid.
8. Last date of receiving offer is up to 3.00 PM on 30th January 2019, in the tender box available over the chamber of GM (HR), TMC Hapania premises. The expression of interest should be submitted in three cover system containing three parts as detailed below.
9. The tender may be open at 3:30PM on the same day (if possible).

PART II: Technical bid to be kept in second sealed cover marked "Technical Bid"

- VI. Technical bid contains literature of the instruments and camera with detailed specification. It is advised to provide the most detailed specifications with usage patterns for the evaluation team to be able to
- VII. Experience or User certificate from the past clients where installation of such camera done/undergoing with satisfactory or good remarks, is preferred.
- VIII. The bidders must include warranty for 2 (two) years for the equipments from the date of completion of satisfactory installation.
- IX. Failure to comply with this condition might entail rejection of the bids.
- X. The payment of AMC will be made on bill basis after submission of satisfactory service report duly signed by the in-charge of respective department.

PART III) Commercial bid to be kept in third sealed cover marked " Financial bid"

- XI. Rate should be clearly typed both in words & figures against each item & should be quoted in Indian currency.
- XII. Bidders shall submit rate of AMC for 5 years after expiry of said warranty period for the equipment. Rate of AMC per year should not be more than 3% of total cost of the machine.

Part I, Part II & Part III should be kept in a separate cover.

Thereafter the covers shall be kept in one big cover and sealed. Bidders should take care in putting the documents as described; otherwise the bids will not be considered. The Chief Executive Officer, SFTMC will accept only one cover duly sealed and stamped at the holdings. The cover should read expression of interest for installation of CCTV for Tripura Medical College & Dr. BRAM Teaching hospital, Hapania, Agartala also indicating thereon:

The prices should not be indicated in the " Pre-Qualification Bid" and" Technical Bid".
